## NEW ROCHELLE SEPTA GRANT GUIDELINES:

1. SEPTA is providing grants district-wide to promote inclusion and a unified school community.
2. Grants will be available to all teachers and staff members (general and special education) who wish to fund a project related to special needs issues specifically a) After School/ Recreational Activities focusing on Music, Art and Technology, b) Integrated Activities that focus on collaboration of general education and special education students, c) Vocational and pre-vocational community based activities and d) Reading and Math Literacy Programs.
3. Grants can be available for courses or workshops that will enhance the teacher's ability to work with children with special needs either in the general or special education classroom (behavioral, technological, emotional or academic issues).
4. The Maximum Grant amount per person is \$250 per person. The Maximum Grant amount for an integrated project is \$500. However, the Grant Committee will review and consider special projects that promote inclusion.
5. The SEPTA Grant Committee will review all Grant applications. All requests will be accepted and/or rejected based upon relevancy and upon funds available.
6. Grant applications will be reviewed on a rolling basis.
7. Reimbursement for Grants will be provided to recipient after all receipts or proof of completion of courses or projects have been submitted to SEPTA.
8. Within 30 days of completion of a grant-funded project, the grant recipient will submit to the SEPTA Executive Board a synopsis (for publication) detailing the program's success, number of participants that benefited from project, and any other pertinent information. Parental/guardian approval for any pictures or quotes must be obtained by grant recipient prior to publication of any information and prior to submission to the SEPTA Executive Board.
